West Shore RCMP received **25515** calls for service in 2024. West Shore RCMP currently has 119 sworn police officers, 1 Civilian Member and 40 full time Municipal Staff.

West Shore RCMP Langford Police to Population ratio is approximately 1:725, based off of 119 officers and population in Langford of 55 025 (population figures come from Government of BC 2024 estimates).

Similar demographics of Saanich and Victoria are listed below for comparison sake:

- *Saanich Cop to Pop ratio 1: 688, based off of 185 police officers in Saanich and population of 127 331
- *Victoria Cop to Pop ratio 1: 411, Based off of 250 police officers and population of 102 951

This year, files decreased overall by 6% (1103 files), with a 4% (914 files) decrease in Langford.

The overall decrease may be attributed to:

- Danbrook Park when the encampment in Danbrook Park was taken down, files decreased in that area significantly. Police attended the park 222 times in 2023, and only 9 times in 2024.
- However, Calls have significantly increased in area of Jacklin Rd / Rex Rd from 51 calls in 2022 to 145 calls in 2024 representing a 184% increase, most notably the call volume in this area increased the most in the second half of 2024 (65 calls from July-Dec 2024)
- Targeted property crime initiatives The Crime Reduction Unit worked all year on a targeted shoplifting initiative.

Although files decreased, they increased in specific areas:

- Persons offences have increased from 741 files in 2023 to 834 files in 2024, representing a 12.5% increase.
- Criminal Code Traffic Offences are up from 144 files in 2023 to 177 files in 2024 representing a 22% increase.

- CDSA (Controlled Drug and Substances Act) offences are up from 55 files in 2023 to 70, representing a 27% increase.

Langford accounts for 53% of the population of the West Shore area.

In 2024, Langford accounted for 56% of all files in the West Shore, but accounted for:

- 60% of all person offences (834/1386)
- 62% of property offences (1596/2515)
- 57% of all fraud files (298/520)
- 59% of Mental Health calls (calls with a mental health component, not just apprehensions)
- 65% of offences involving a youth perpetrator

¹ Population based on 2023 estimates, no data for 2024 at this time. 2023 Population figures are projections & calculated by E Division Data Analysis Unit. A running average is calculated by using the previous 5 years of population data (2018-2022) & the 2023 population is an estimate.

Files have increased in Langford in the categories of Persons Offences, CDSA Offences, Provincial and Federal Acts, and Criminal Code Traffic Offences.

Files have decreased in Langford in the categories of Property Offences, Other Criminal Code Offences, and Non-Reportable file types.




Figure 4: 2023 vs 2024 Offence Types, Langford

PERSONS OFFENCES - LANGFORD (VIOLENT CRIMES)

Persons offences include: Assaults (all), Utter Threats, Harassment, Sexual Assaults and other sexual offences, Robbery, Kidnapping, Extortion, some Arson

60% of the persons offences in 2024 occurred in Langford. The most common person offences in Langford were: Assault, Uttering Threats, Harassing Communications, Assault with a Weapon, and Sexual Assault.

 Persons offences have increased – theses are larger more complex investigations, more time consuming, Higher-risk to public and personal safety; from 741 files in 2023 to 834 files in 2024 representing a 12.5% increase.




Figure 6: Persons Offences by Municipality




Figure 7: Top 5 Persons Offences in Langford




Figure 9: Property Offences per Municipality




Figure 10: Top 5 Property Offences in Langford

Property offences have been trending upwards over the last 5 years. Langford did experience a slight decrease in property offences in 2024.




Figure 11: 5 Year Comparison: Property Offences Per Municipality




Figure 12: Top 5 Fraud Types

In 2024, there were 520 Fraud files in the West Shore. 298 of those Frauds occurred in Langford, accounting for 57% of all fraud reports.

In 2023, there were 528 Fraud files, with 311 occurring in Langford, accounting for 58% of all fraud reports.




Figure 13: 5 Year Trend: Fraud Offences in Langford

² For the purpose of national police-reported statistics, cybercrime encompasses any criminal act as outlined in Canada's Criminal Code where Information and Communication Technology (ICT) is the target of the offence, or whereby ICT is integral and vital in the commission of the offence. ICT includes, but is not limited to, the internet, computers, servers, digital technology, digital telecommunications devices, phones and networks. Texting, messages on Facebook and Twitter for example are all to be considered as cybercrime activity if a criminal offence (such as uttering threat or criminal harassment) is involved.

CYBERCRIME, EXTORTION, CHILD SEXUAL ASSAULT MATERIAL (CSAM)3:

Overall Cyber crime has been on the rise in West Shore. This is a part of a larger trend we are seeing across the nation with emerging technologies, including Artificial Intelligence, and increasingly sophisticated cyber scams.




Figure 14: 5 Year Trend: Cybercrime (All of the West Shore)

Extortion files are slightly down this year compared to 2023, however it has greatly increased overall in the past five years – from 12 files in 2020, to 53 files in 2024, representing a 341% increase. "Sextortion" scams and youth victims were a significant portion of these files.

In April 2024, West Shore RCMP Mental Health Unit was established which pairs a police officer with a registered nurse who specializes in mental health and substance use care, together they respond to mental health calls for service. The unit has been well received by the community and they have responded to approximately half of all mental health calls received.

Langford had 1121 files related to Mental Health in 2024. Of those files, police officers spent nearly 400 hours at these calls.




Figure 19: Mental Health Files by Municipality

YOUTH RELATED OFFENCES - WEST SHORE

In 2023 there were 296 investigations involving youth who were listed as the main perpetrators. In 2024, there were 267 investigations, representing a 9% decrease. The youth involved in these investigations were classified as either Charged, Charges Recommended, Suspect Chargeable, Or Suspect. Figure below depicts the percentage of crimes involving youth per community in 2024.




Figure 20: Percentage of Crimes involving Youth Perpetrators
